TOWN OF STARKSBORO, VERMONT SPEED ORDINANCE

Pursuant to the provisions of Title 23, Vermont Statutes Annotated, Section 1007 and 1008, and Title 24, Vermont Statutes Annotated Sections 1971 and 2291(1)(4) and (5), and such other general enactments as may be material hereto, it is ordained by the Board of Selectmen of the Town of Starksboro that the following Speed Ordinance is adopted for the Town of Starksboro, Vermont.

Section I: Definitions

The definitions of Title 23, Vermont Statutes Annotated, Section 4 are incorporated by reference.

Section II: Scope

The ordinance establishes speed limits on public highways within the Town of Starksboro as specified in Article IV.

Section III: Severability

The provisions of this ordinance are declared to be severable and if any provisions hereof be adjudged invalid such judgment shall not affect the validity of any other provisions.

Section IV:

The following speed limits are hereby established.

- B. The penalty for violation of any of the above speed limits shall be set by the Schedule of Fines established by the State of Vermont.

Section VI: Enforcement Officials

Issuing officials shall include any officer of the Addison County Sheriff's Department.

Section VII: Effective Date

This ordinance is hereby adopted on November 13, 2018 and shall become effective on February 1, 2019. This ordinance supersedes any previously enacted speed ordinances.
