- 9. Benchmarking Town Buildings Project Update
 - a. Training update
 - i. Celine won't be trained before she leaves
 - ii. Robert Turner suggested by email looping back after we have a new treasurer in place
 - iii. We should wait to upload the data until we can do it while training a new treasurer

 - b. \$25 million Gov allocated in his budget address for weatherization
- 12. Town Solar Trackers
 - a. The 10 years term for the \$.06/kWh adder will likely be dropped shortly
 - b. Therefore, the monthly credit will drop and we'll have less \$ to apply to the group of buildings
 - c. We were meeting 80% of load
 - d. \$20/month/meter service charge will no longer be able to be credited
 - e. We need to have a discussion about bill allocations as all this changes with the new treasurer
 - f. We would like to go to the Select Board with the new treasurer backing us up with Robert as we make any solar
 - g. We need a complete plan before we go to the Select Board
 - h. Jeff will research GMP website to better understand where and when the solar adder is going away
 - i. Keep tabs on the Gov's new \$10 million community solar proposal
 - j. Tracker Communications Update

- i. Jeff had worked with AllEarth to get communications back in action and that software was updated and communications and data are now flowing
- ii. The School is fine with keeping the connection
- iii. The Select Board ask the Energy Committee to be the point of contact for AllEarth
