- 5. Energy Grant Resources for Town Buildings
 - a. Act 172 (MERP Grant) Opportunity
 - i. Projects under consideration:
 - 1. Library HVAC project
 - 2. Jerusalem School House HVAC & possibly weatherization
 - 3. Solar on Pavilion
 - ii. Rebecca Elder will be working on grants for these applications
 - iii. Part of this funding includes \$4,000 that can be spent for a town event promoting energy awareness (see next section)
 - b. Town Event
 - i. Town gathering is being considered for June
 - 1. June 17 would work best for Jeff, Rich and Richard
