1. Call to Order	The meeting was called to order at 4:35 pm.
2. Opener	What is your favorite type of pie? Three berry pie Strawberry pie Milk pie Grapefruit pie Apple pie Shepherd's pie - savory over sweet
3. Approval of Sept Minutes	Discussion - Motion to approve minutes as written - Katie Second - Christa All in favor; motion passed
4. Librarian's Report	Planning for events has kept the library busy, including the Memorial for Liz Fairchild Saturday, 10/14 and the upcoming Piano Crawl featuring David Feurzeig, Friday, 10/20. For the Town Harvest festival, Catherine will bring the library's sticker project and have a board where people vote for their favorite genre. Katie will be there 3-5. Catherine posted on FPF about the upcoming open library technician position and storytime. The library clerk position description needs a revision. Question: can we afford to pay for some wider advertising? Can we post on the library list-servs? Lynn's last day is Dec. 15. Catherine asked for one volunteer from the Board to participate in interviews. Wages will be based on experience.

Town Hall Accessibility Committee:

- The Town Hall Committee was notified that the Selectboard will not pursue a site plan at this time. The Town Administrator plans to be in touch with District 5 AOT to ask some questions about 116 and accessibility in front of the building.
- The library was notified that it was awarded \$45,966 in municipal ARPA funding to match the VT Arts Council's Cultural Facilities \$30k grant for the vertical lift project.
- Regarding the \$20k American Library Association Grant for improving the first-floor's accessibility, Catherine reported that the original entry slope was designed to be 1:20 (an accessible path maximum) and 19' long. In reality, the slope is actually 1:12.5 and is 17' long. Mark Lucas has volunteered to help confirm Catherine's measurements. Improvements we believe we will need include a flat landing at the bottom; an alternate surface (honeycomb); and most likely a railing. This work will need a new architectural design and state permits. Katie offered the Board's November meeting for a Community Conversation, which is a requirement of the ALA organization before any monies may be spent. No decision was made.
- For the purpose of piano crawl, our understanding is that current fire safety regulations require us to have 49 people or less; ideally we will have a second egress in the future so that we can reach our capacity of 200 people for this square footage.
- Next steps: ALA Conversations, Town Hall Committee second egress discussion
