- Report on poison parsnip and other invasives' removal

- Update on Municipal Planning Grant grant for doing community land trust work and gathering information about housing. Consultant to research community land trusts. Mechanism to promote affordable housing in Starksboro. Potential consultants have been interviewed, both are very

qualified. Next Wednesday the findings presented to Planning Commission. Once the consultant is hired, there will be three public engagements to discuss findings. The work will happen over summer and fall.
